Biological Weapons

COVID-19 Vaccines

We are a not-for-profit with the objects of promoting vaccine safety and efficacy, with a membership of over 2,250 concerned Australians.


1. As you may be aware, alarming reports have recently emerged that the Wuhan laboratory known for first detecting SARS-CoV-2 may be involved in the production of biological weapons. These are fuelled by Chinese government 2015 reports of weaponizing the SARS virus, reports and testimony from Chinese ex-Wuhan lab scientist turned whistleblower Li-Meng Yan and a scientific paper by international virologists Sorenson, Dalglish and Susrud that the SARS-CoV-2 virus is of unnatural origin.
2. I understand that your department administers the *Crimes (Biological Weapons) Act 1976* ("CBW Act") which implements the United Nations *Biological Weapons Convention 1972* ("BWC Convention") prohibiting the acquisition, stockpiling and retention of microbial agents that have no justification for peaceful purposes and any delivery means designed to use those agents for hostile purposes (section 8; article 1).
3. It is no secret that China has for some time been pursuing political interests in conflict with our own. During the COVID-19 period, China has taken an increasingly hostile stance in numerous areas. In April 2020, the Morrison Government backed

down from calls for an independent investigation into Wuhan as the epicentre of the pandemic following threats of trade sanctions by China, fuelling suspicions of a cover-up. In addition, despite its dense population and cultural practices, and unlike Western countries, China appears to have mysteriously emerged from the COVID-19 crisis without serious impacts on its society and economy.


4. China is known to not 'play by the rules' when it comes to the use of high-tech covert means to obtain political, military and commercial advantages. Many credible U.S., U.K. and Australian reports have warned about various aspects of Chinese technology in these areas, including the harvesting of our genetic information and electronic surveillance by Chinese corporations as 'fronts' for the Chinese government.
5. The COVID-19 vaccines are all designed from the SARS-CoV-2 'spike' protein, which primarily originates from a computer program in the Wuhan lab, and for which no purified viral isolate has yet been produced anywhere in the world. It is eminently foreseeable that the spike protein may have been designed to serve Chinese interests such that the vaccine manufacturers would unwittingly produce a bioweapon based on the Wuhan viral template and disguised as a vaccine to be enthusiastically accepted by the west like a micro-Trojan Horse.
6. This hypothesis accords with the high volume of adverse vaccine reactions and 'breakthrough' COVID cases reports, showing an appalling safety and efficacy record for the experimental vaccines to date, and particularly in the emerging evidence of cardiovascular, neurological and immunological damage caused by the toxic spike protein. It may also explain why COVID-19 vaccines are not even rated to prevent viral infection or transmission. These incongruities are generating significant division within Western nations and prompting governments to perpetuate destructive measures in response to the low morbidity and mortality risk of COVID-19 in Australia and elsewhere.
7. There is therefore a real risk that the Commonwealth Government, in its rush to acquire, retain and stockpile COVID-19 vaccines and their constituents, may be committing multiple continuing contraventions of section 8 of the CBW Act and breaching its civil duties arising under the BWC Convention. If the SARS-CoV-2 virus has been designed to stimulate the production of microbial agents for hostile purposes, any purported justification for the use of such agents as legitimate vaccines evaporates as a sham and a dangerous falsehood.
8. Under the circumstances, we urge the Commonwealth not to neglect its role under the CBW Act and the BWC Convention, and to impose an immediate suspension on

the COVID-19 vaccinations pending the outcome of a thorough investigation into the aetiology of the SARS-CoV-2 virus. Should the Government not suspend the rollout within 7 days, we may need to instruct our lawyers to take action in the Courts seeking urgent injunctive relief without further notice.
